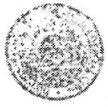

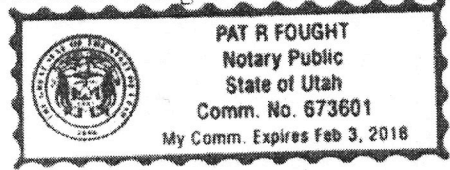

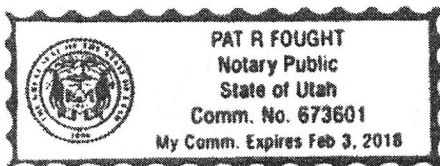

ARTICLE I

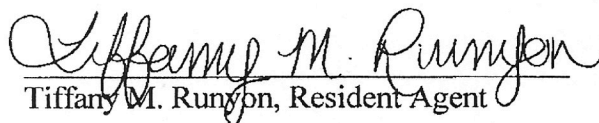
