Dear Bishop Dan Greenland of the Kearns 6th Ward,

This is to inform you that as of June 16, 2001 we have terminated our membership in the Church of Jesus Christ of Latter-day Saints. As of this date we are no longer to be considered members of the Church. We no longer consider you or anyone else in the church to have authority over us. We will not meet with you at your office concerning this matter and do not want anyone to visit us. You do not have the right to retain our names on the church's membership list as of this date. We are not requesting a favor from you in this matter. We have the right to terminate our membership whenever we choose.

The Church Handbook of Instructions states that the Bishop is to wait 30 days before finalizing this action. We therefore request a letter confirming that our membership has been terminated after the 30 day period. This would officially be July 16, 2001. The word "Excommunication" is not to be used in your confirmation letter or on the records of the church. We are quitting, - the church did not "fire" us. We will start a writing campaign to the newspapers to inform them of the church's control and unfairness in this action if this request is not met. We may be forced to seek legal action if we do not hear from you after July 16, 2001.

The reason for this action is that we know the church is not true. The church over time has falsified, suppressed, and deceived its members as to the history and veracity of the church. The accounts of early church history made known to the average member are more myth than reality (We site a few examples on the following pages enclosed).

We are not enemies to the church or any man. We wish only good to come to all. We are sorry if we have hurt anyone's feelings including yours. We hope you will have peace in this matter.
